Parents Evenings

Medical Appointments

We appreciate that it is not always possible to get medical appointments outside of school hours. However, please be reminded that time missed for appointments is counted within your child's attendance. If at all possible please try and arrange any routine appointments outside of school hours.

In any case of a child having to leave school for a medical appointment, an appointment letter, card or slip must be presented to the school office.

Online Safety

We have had an increase in children reporting that they are accessing various sites, apps and online programmes that potentially could contain inappropriate material for their ages or be beyond their emotional maturity. In many cases, parents have been unaware of age restrictions on the particular sites. We have therefore included a list of common sites with their age restrictions for your reference:

- YouTube 13 years old to have an account

On some platforms, protocols are in place to protect users until they are 18 years old. So a 13 year old subscribing may have protection for 5 years until they are 18. However, if a child is only 9 but declares they are 13, that 5 year protection would run out when they are 14 years old.

Children online can be at risk in two ways:-

Content – Content uploaded online is rarely private. It can be altered, copied, pasted or reposted by anyone. The information is often "owned" by the site once posted. It makes it very difficult to "take back" what may later be regretted. Children who post or create inappropriate, offensive or even illegal content on their own or other's sites could be in serious trouble with school or the police.

Contact – Young people need to be aware of information shared on sites. If personal information is not protected by enabling privacy settings they may be sharing information with strangers, some of whom may have malicious intentions. Posting or chatting about personal details may identify and allow someone to contact a child online or in person or leave the child open to cyberbullying from those they don't know.

If you are unaware of your child's online profile or 'footprint' it is worthwhile having a conversation with them to ensure their data is safe, they know how to stay safe and they are aware of what is appropriate and inappropriate.
