## Children in Need

As you are no doubt aware, Children in Need is next Friday (13 November). Once again we will be supporting this worthwhile charity. The theme this year is "Be a Hero" so we are inviting children to come to school next Friday dressed as their hero. Alternatively, they may just come in non-uniform or, as in previous years, they could come in something spotty.

A donation of £1 per family is suggested, with all money going to Children in Need.

We will also be holding a Pudsey Bear colouring competition. Children will receive an outline of Pudsey for them to colour/decorate as they wish. Entries should be brought to school on Children in Need day.

### Car Parking

Over the past few weeks I have received several complaints about car parking: particularly close to the Sycamore Centre, Sherbourne Villas and Sherbourne Park. In some cases, access to property has been blocked and in one case a Fire Engine was blocked due to parked cars at home time.

I appreciate that car parking is an issue. However, please be aware of your surroundings when parking. I will continue to work with the County Council to explore solutions to the car parking.

In addition, I have been notified by the Council that they are introducing a Parking Enforcement Vehicle. The vehicle will monitor parking outside schools via camera. Vehicles parked in contravention to regulations may be issued with a Penalty Charge Notice. More information on the vehicle is available on their website
